

## **RULES: IIR MERIT MEDAL**

*This IIR Merit Medal is a high-level honour awarded to a person with noteworthy achievements who has made exceptional contributions to the IIR, and who also serves as a role model to the younger generations.*

### **IIR MERIT MEDAL**

*which will be given out at the 27th IIR International Congress of Refrigeration in Seoul (Republic of Korea) on August 21-27, 2027*

## **I – GOALS**

*The prize is awarded to a person who has made exceptional contribution to the IIR through lifelong honorary membership of the organisation.*

## **II – AWARDING OF THE MEDAL**

*The winner of the IIR Merit Medal will receive:*

- *a medal*
- *honorary membership of the IIR*

*The medal is awarded on the occasion of IIR International Congresses of Refrigeration and will only be awarded if the prize-winner attends the Congress; they will be proposed as a speaker or as a chairperson of one of the technical sessions of the Congress, and will be cited in the different IIR communications.*

*The Medal will be handed out by the President of the General Conference during a session of the Congress. The prize-winner will be able to give a short speech (max. 10 minutes).*

## **III – NOMINATION**

*Applications are not limited to persons from IIR Member Countries; active officers of the IIR (head office staff) are not eligible.*

*The nomination shall be supported by a sponsor who is member of an IIR Commission. The sponsor shall look for further support from one other Commission member. All people involved in IIR activities (IIR delegates and members, organizers of IIR*

*conferences, Editors of the International Journal of Refrigeration, national refrigeration organisation officers, etc.) are encouraged to make proposals.*

*The sponsor may also be supported by the Head of a Section or President of an IIR Commission, or by a Member Country Delegate (if one of the sponsors does not hold one of these functions).*

*Each nomination package must include:*

- *the completed nomination form*
- *the candidate's curriculum vitae (résumé) (see details in the nomination form), including a good quality photo ID, preferably in colour*
- *presentation of the candidate by the sponsor, with an assessment of the candidate's career in science and/or practice, with a detailed explanation of the candidate's achievements referring to the criteria given above for the prize (See Section I)*
- *the statement of the designated person as indicated above*

**Each nomination package must reach the IIR by November 15, 2026 (9pm Paris time). Send a PDF version of the package by email to [communication@iifiir.org](mailto:communication@iifiir.org).**

## **IV – SELECTION OF THE WINNER**

*The Science and Technology Council of the IIR shall determine which commissions are relevant for evaluating the nominations. The final decision will be taken by the members of the Science and Technology Council appointed to the Management Committee, together with the President of the Science and Technology Council and shall be announced to the winner in the early part of the year of the congress, so that they can arrange to attend the Congress. Only one winner will be selected per award.*
